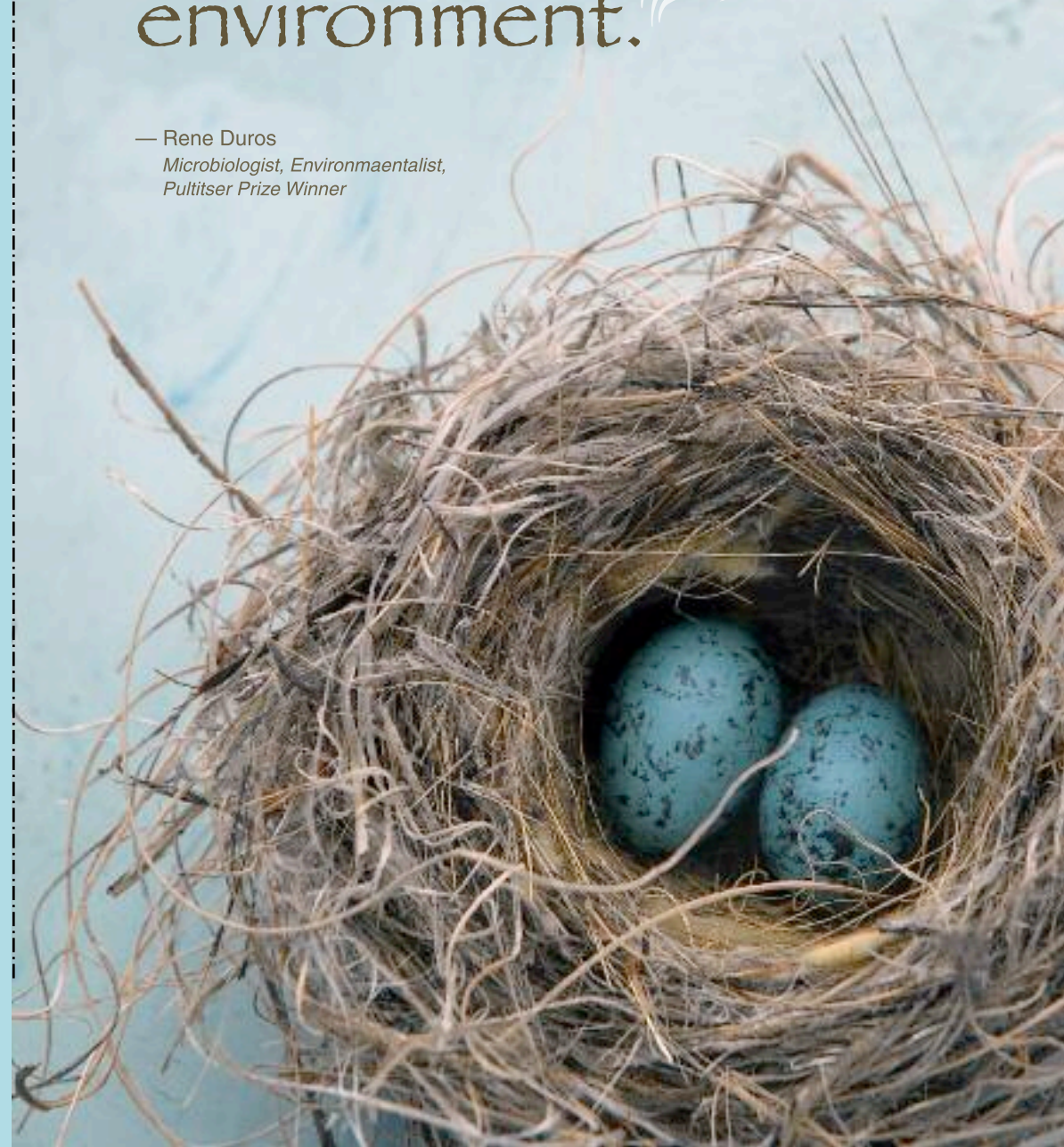

2010 NC Zoo Society Annual Report

Dear Donors,

Despite the economic difficulties that have touched so many families in North Carolina, the NC Zoo Society completed 2010 by posting its third-highest revenue year in history. Only 2002 and 2008 recorded higher fund-raising successes. In 2010, the Society's net, after all expenses, approached \$5 million, which was set aside to support the education, research, conservation and recreational missions of the North Carolina Zoo and the NC Zoo Society.

A significant portion of the year's major gifts arrived from the estates of loyal friends who remembered the NC Zoo Society in their wills. Most notably, Dr. Anton Schindler's estate provided \$1 million to support the continued operation of the Valerie H. Schindler Wildlife Rehabilitation Center, the Valerie H. Schindler Wildlife Learning Center and the North Carolina Zoo's pachyderm breeding programs. The estates of Herman Cone, Joan Hill and Millicent S. Marsden combined to provide nearly \$250,000 for Zoo programs.

Bob and Bonnie Meeker, The Timken Foundation of Canton, the Randolph Friends of the Zoo and the Cannon Foundation made significant donations supporting the Zoo Society's top fund-raising priority in 2010: A capital initiative to upgrade and expand the NC Zoo's Polar Bear exhibit. The proposed changes will align the exhibit to the standards required to house up to six Polar Bears and will include a breeding den (with the potential for cubs) as well as extensive educational graphics and experiences for everyone who visits the improved exhibit.

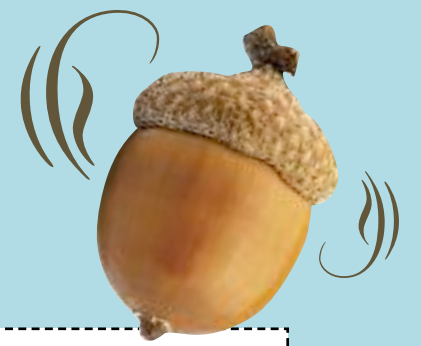
During 2010, the NC Zoo Society turned over \$2,205,731 to the North Carolina Zoo. These donations provided continuing support for the Zoo's most vital programs, including its field conservation and education programs in Africa and its veterinary, education and animal welfare needs in Asheboro. The Zoo's leading African field programs center on Cross River Gorillas in Nigeria, African Elephants in Cameroon and conservation education in Uganda. Internationally, Zoo Society funds also reached into Egypt and Afghanistan to provide training and support that will improve the quality of care zoo animals receive in both countries. Many of these animal initiatives appear on the NC Zoo Society's award-winning Web site Field Trip Earth, www.fieldtripearth.org.

The Society's capacity to fund these and other programs grew from its continuing success in securing donations from individuals, corporations and foundations and from its strong membership and gift shop revenues. Taken together, membership and gift shop sales earned more than \$2 million in revenues in 2010.

While serving its members and other donors in 2010—and into 2011—the NC Zoo Society has adjusted to the state's slowed economy by tamping down its expenses in ways that will not degrade the services it extends to its members and to its partner, the North Carolina Zoo. This heightened attention to costs helped shape the Society's decision to condense this year's Annual Report. Our goal is to thank the donors who made our successes possible **but** to express this gratitude in a way that saves money, paper and other resources.

This shortened **annual report expresses** our renewed to commitment to respect **you**—our friends and donors—**you while** reducing our costs. The following pages list the people and the organizations that provided particularly generous gifts in support of the Zoo's missions in 2010.

We thank you—and all our other donors—for underwriting so many of the programs that allow the North Carolina Zoo to serve audiences here at home and plants, animals and people all over the world.

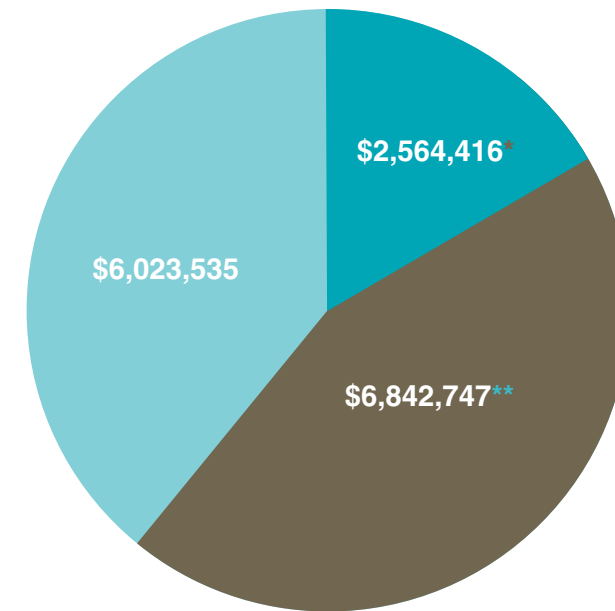

Funds Transferred to, and Awaiting Requisition from, the North Carolina Zoo



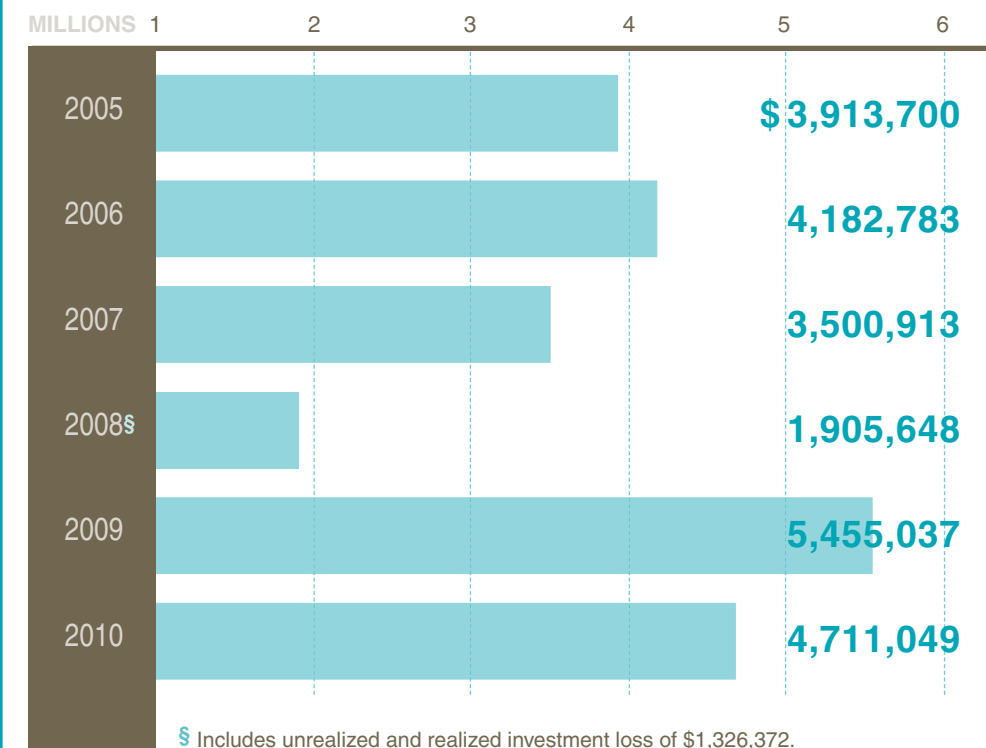
